PURPOSE OF DATA PROCESSING

We process your data for the following purposes:

- Fulfilling legal obligations

LEGAL BASIS

We process your data based on:

- Your explicit consent
- Pre-contractual or contractual necessity
- Our legitimate interest
- Compliance with legal obligations

DATA SHARING

Your data may be shared with trusted technical service providers (e.g., hosting, analytics), solely to fulfill specific functions. These partners are obligated to ensure data security and confidentiality.

If data is transferred outside Switzerland or the EEA, we ensure adequate protection through standard contractual clauses or equivalent safeguards.

DATA RETENTION

We retain your data:

- As long as needed for the stated purposes
- According to legal obligations (up to 10 years)
- Until you withdraw your consent, where applicable

YOUR RIGHTS

Under the nFADP, you have the right to:

- Access your personal data
- Request rectification or deletion
- Object to certain processing
- Withdraw your consent at any time
- Request data portability
